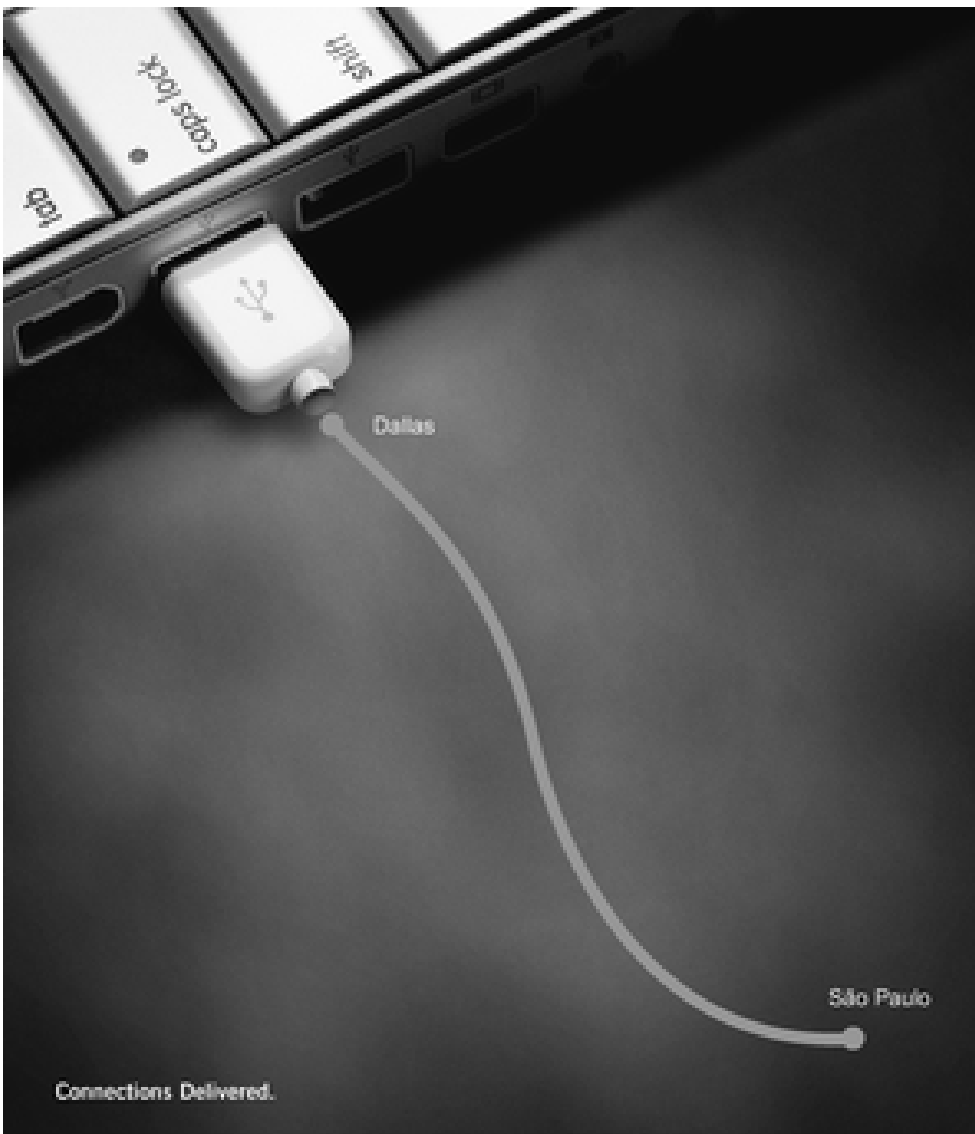

New Hazmat Reporting Requirement effective July 1st

Since I had some space to fill, I thought I'd mention that starting July 1st, freight forwarders and cartage agents will be required to report any **undeclared** Dangerous Goods Shipment to the US DOT. **THIS IS A BIG CHANGE.** In the past forwarders have not been required to turn in their customers (it's always been an air carrier requirement, but now it will apply to forwarders, truckers and anyone else in the supply chain).

Visit **www.dgtraining.com** click on "enforcement" to download a copy of the DOT Form 5800.1 form that you have to fill out and submit. Needless to say, your customers need to be aware that if you discover a DG shipment, you are not going to be able to simply return it, you'll have to report it!
